

Armando Salas & Crappie Sniper Guide Service

Waiver & Release of Liability Claims and Assumption of Risk Acknowledgement

ALL PATRONS, CUSTOMERS & GUESTS of Armando Salas and Crappie Sniper Guide Service (together “CRAPPIE SNIPER”) must complete and sign this Waiver & Release of Liability Claims and Assumption of Risk Acknowledgment (the “Waiver”) before the beginning of any guided fishing trip.

I hereby acknowledge that participating in fishing trip presents a risk of personal injury, death and damage or loss of personal property which may result from, but is not limited to, the following: fishing active bodies of water; boarding and un-boarding of watercrafts; natural hazards including lightning storms and other adverse weather conditions; domestic or wild animals; fire; travel either on foot or in a vehicle in unfamiliar terrain; artificial and natural obstructions and unimproved roads; as well as traveling in vehicles owned, leased or otherwise used by CRAPPIE SNIPER.

I hereby acknowledge and recognize the existence of these risks, and **ASSUME ALL RISKS COMPLETELY, and agree that I SHALL HOLD HARMLESS AND TAKE NO ACTIONS OR SUITS, FOR DEBTS, DUES, SUMS OF MONEY, CLAIMS OR DEMANDS WHATSOEVER AT LAW OR IN EQUITY AGAINST CRAPPIE SNIPER** and its owners, agents, representatives, employees or immediate relatives, his/her heirs, executors, assigns, administrators, property or other guides, aides or associates for injury, death, property damage or loss associated with relating to or arising from those risks enumerated above or otherwise that occur while I am participating in any stage of a fishing package trip(s) with said guide services.

I understand and acknowledge that by signing this document that I have given up certain legal rights and/or possible claims, which I might otherwise assert or maintain against CRAPPIE SNIPER and its owners, agents, representatives, employees or immediate relatives. These rights are specifically, but not limited to, rights arising from claims or demands for acts of omissions or negligence in any degree of CRAPPIE SNIPER and it’s owners, agents, representatives, employees or immediate relatives. Under no circumstances will CRAPPIE SNIPER or and its owners, agents, representatives, employees or immediate relatives be held liable for damages in excess of the price of the guide services.

I understand that this Waiver applies to all trips I participate in with CRAPPIE SNIPER. I further state that I am of lawful age to sign this Waiver or that I am signing it on behalf of a minor for whom I legally responsible.

I acknowledge that I have reviewed (or at least been given an opportunity to review) the Frequently Asked Questions (FAQ) document on the Crappie Sniper Guide Service website at crappiesniper.net and understand and accept the stated terms of service including, but not limited to, the payment rates and provisions, and cancellation provisions, and that the guide service is provided on a “best efforts” basis with no guarantees, including but not limited to, the size and number of fish that you may catch and/or keep. Trips may be shortened or terminated, at CRAPPIE SNIPER’s sole discretion, for reasons of non-compliance with reasonable requests regarding safety, bad behavior, and other adverse circumstances, and the full payment amount will nonetheless be due and payable.

I acknowledge and consent to the free use by CRAPPIE SNIPER of any and all photos or videos of me or my child/ legal minor associated with the trip or trips for social media, promotion or other related purposes.

I understand and agree that CRAPPIE SNIPER will reserve the right to any and all recourse under the law to recover the guide service fee and charges for equipment lost or broken by me or my child/minor (if any) that is due in full at the conclusion of the trip, in the event of my non-payment, under payment or withholding of payment.

I understand that this Waiver reflects our entire agreement and that by my signature, I acknowledge that I have read and understand the terms and provisions of this instrument and that I have signed this Waiver of my own free will.
